Essential Qualifications:

- (i) Officer of Central/ State Governments or Public Sector/ Autonomous Organizations/ Colleges/ Universities/ Educational Institutes:-
 - a. Holding analogous posts.
OR
Holding post in the pay scale of PB-2 Rs. 9300-34800 with GP-4200 (corresponding Matrix Level-6, as per 7th CPC) in regular basis for 5 years service.
- (ii) Minimum three years of experience in training of which at least one year should be in Water Sports.

Age limit : The maximum age limit is 56 years as on closing date of receipt of application.

GENERAL TERMS AND CONDITIONS FOR DEPUTATION POST

- i) Completed application as per the prescribed format duly forwarded through proper channel should reach the **Administrative Officer, Indian Institute of Tourism and Travel Management, Govindpuri, Gwalior (MP)- 474 011** latest by **15th February, 2019**.
- ii) The selected official shall be on deputation for a period of one year initially on which can be extended depending on the requirement. Candidates should submit their applications through proper channel along with their APARs for the last 05 years, certified by a Concerned Officer along with Cadre clearance and Vigilance clearance respectively.
- iii) Applications should be **supported by relevant documents (attested)** in all respects. Applications not supported by relevant documents as prescribed, will be summarily rejected.
- iv) No TA/DA shall be paid to the candidates for attending the interview.
- v) IITTM will not be responsible for any postal delay.
- vi) Application received after the closing date or incomplete in any manner shall not be entertained.
- vii) Candidates are advised to satisfy themselves before applying for the post that they possess at least the required minimum essential qualification mentioned in the advertisement/IITTM website.
